## Agricultural prices 1995/1996: extension of the 1994/1995 milk year

Milk: marketing year 1995/1996. Within the context of the reform of the CAP the Council had fixed the target price for milk and the intervention prices up to 30.06.1995. However, as the 1994/1995 marketing year ended on 31.03.1995, the Commission proposed extending the current marketing period, as it had done the previous year, to 30.06.1995 so that the fixing of threshold prices (which was linked to the marketing year) would remain consistent with the level of institutional prices set from 1 July to 30 June of the following year. ?

## Agricultural prices 1995/1996: extension of the 1994/1995 milk year

Milk: marketing year 1995/1996. As in the previous year, Council Regulation (EC) No 682/95 extended the current milk marketing year to 30.06.1995, in order that the fixing of threshold prices, which was linked to the marketing year, would remain consistent with the level of institutional prices set from 1 July to 30 June of the following year. The 1995/1996 milk year was to begin on 01.07.1995. ?
