Agricultural prices 1995/1996: milk and milk products, common organisation of the markets COM (amend. regul. 804/68/EEC)

Milk: marketing year 1995/1996. The Commission proposed fixing the standard minimum protein content for skimmed milk powder for intervention, with the inclusion of refractions for milk powder which did not comply with the set standard. The latter (35%) may be respected by the majority of producers during the period of application of the intervention scheme in the course of the marketing year. This refraction system would ensure that even in those regions where normal protein contents were slightly lower, milk production could still be eligible for the intervention scheme. Aid could be granted for the private storage of skimmed milk powder of top quality. In order to be eligible for aid, the skimmed milk powder should meet the conditions which would be laid down. The amount of aid was fixed in accordance with the storage costs and the likely trend in prices. Aid for private storage was subject to the drawing-up of a storage contract. Skimmed milk powder bought in by the intervention agency should not disturb the balance of the market and should ensure purchasers equal treatment and equal access to the products being sold. The Regulation would apply from 1.03.1996. ?

The European Parliament approved the proposal with certain amendments. The EP opposed the Commission's proposal that skimmed milk powder should have a minimum protein content of 35%; it suggested a minimum protein content of 30%. It also called on the Commission to: - put forward, before the start of the 1996/97 marketing year, a voluntary cessation scheme involving 75% cofinancing for Objective 1 regions

and 50% for other regions, with a view to furthering the restructuring process; - submit by 21 December 1995 a progress report on the milk and milk products market focusing in particular on the minimum requirements for the protein content of skimmed milk powder, together with a legislative proposal if necessary. ?

Milk products - Prices and related measures for 1995/96. The Council adopted Regulation No 1538/95 amending Regulation (EEC) No 804/68 on the common organisation of the market in milk and milk products. Substance: - The minimum protein content should be set at 35.6% (of the non-fatty dry extract) for skimmed milk powder for intervention (from 1 March to 30 August); intervention agencies could, however, buy in skimmed milk powder whose protein content was between 31.4% and 35.6%. In that case, the buying-in price would be equal to the intervention price less 1.75% for each percentage point by which the protein content was lower than 35.6%. - Aid for private storage of skimmed milk powder of top quality should be granted. In order to be eligible for aid, the skimmed milk powder should meet conditions to be fixed. The aid would be fixed in the light of storage costs and the likely trend in prices. Private storage aid would be subject to the drawing-up of a storage contract. - Skimmed milk powder bought in by the intervention agency should be disposed in such a way so as to avoid disturbing the balance on the market and to ensure purchasers equal treatment and access to the products to be sold. The Regulation should apply from 1 March 1995. ?
