Agricultural prices 1995/1996: target price for milk and intervention prices for butter and skimmed-milk powder

Milk: agricultural prices 1995/1996. The Commission proposed fixing the target price for milk and the intervention prices for milk products, for the period from 01.07.1995 to 30.06.1996, as follows: - Target price for milk: ECU 30.68 per 100 kg (reduction of 1% compared with the 1994/1995 marketing year); - Intervention prices: . butter: ECU 321.64 per 100 kg (reduction of 2% compared with the 1994/1995 marketing year); . skimmed milk powder: ECU 205.52 per 100 kg (no change). The Regulation would apply from 1.07.1995. ?

Agricultural prices 1995/1996: target price for milk and intervention prices for butter and skimmed-milk powder

Although aware that neither the Commission nor the Committee on Budgets were in favour of a 1% linear increase in all prices, the rapporteur, Mr HAPPART, urged Parliament to give farmers a sign of hope and support the most disadvantaged areas in Europe. Mrs FRAGA, speaking before the vote, asked if the Commission intended to take over the amendments on the target price for milk and the intervention prices for butter and skimmed-milk powder, since Parliament was calling for the intervention price to be maintained at the level of the previous marketing year given that butter stocks were at the limit of the security threshold. The Commissioner considered that the 2% decrease in the intervention price proposed by the Commission was an indication to producers that they should not subsequently increase the fat content of milk.

Agricultural prices 1995/1996: target price for milk and intervention prices for butter and skimmed-milk powder

The European Parliament approved the proposal with certain amendments. The EP recommended maintaining the intervention price for butter at the level of the previous year, namely ECU 328.20 per 100 kilograms. It therefore rejected the 2% reduction proposed by the Commission: such a reduction would lead to a fall in the price of milk paid to the producer, which was unacceptable, especially since it would not benefit the consumer. ?

Milk products - Prices and related measures for 1995/96. Council Regulation (EC) No 1539/95 maintained, for the period from 1 July 1995 to 30 June 1996, the target price for milk and the intervention prices for milk products at the level of the last marketing year, in other words: - Target price for milk: ECU 30.98 per 100 kilograms; - Intervention prices: . butter: ECU 328.2 per 100 kilograms; . skimmed milk powder: ECU 205.52/100 kilograms. The Regulation should apply from 1 July 1995. ?
