Beef and veal: agricultural prices 1995/1996. It was proposed that for the 1995/1996 marketing year the guide price for adult bovine animals be maintained at the same level as in 1994/1995, namely ECU 238.39 per 100 kg live weight. ?

The European Parliament rejected the request by its Committee on Agriculture for a 1% increase in agricultural prices for 1995/96. It approved the Commission proposal. It called essentially for the introduction of greater flexibility in the premium schemes and clarified the procedures for granting a special premium for male bovine animals for 1995/96. ?
