Agricultural prices 1995/1996: basic price and standard quality for pig carcasses

Pigmeat: agricultural prices 1995/1996. The Commission proposed reducing the basic price by 3.8% compared with the 1994/1995 period in order to take account of the reduction in the price of cereals. As a result, for the period from 01.07.1995 to 30.07.1996 it was proposed fixing the basic price for slaughtered pigs of the standard quality at ECU 1,509.39 per tonne. The standard quality was defined in terms of carcass weight and lean meat content and was determined as follows: - carcasses weighing 60 kg to less than 120 kg: grade E, - carcasses weighing 120 kg to 180 kg: grade R. ?

Agricultural prices 1995/1996: basic price and standard quality for pig carcasses

The European Parliament approved the Commission with certain amendments. The EP recommended that the basic price for slaughtered pigs be set at ECU 1569.76 per tonne (instead of ECU 1509.39 per tonne). It also called on the Commission to: - submit by 21 December 1995 a report and relevant proposals on ways of stabilising the mechanisms used to set the market price for pigmeat and, in particular, of restricting the size of holdings and the use of intensive farming methods; - submit a method of calculating the basic price automatically on the basis of objective criteria. ?

Agricultural prices 1995/1996: basic price and standard quality for pig carcasses

Pigmeat - Prices and related measures for 1995/96. Council Regulation (EC) No 1541/95 reduced the basic price by 3.8% with respect to 1994/95 to take account of the reduction in the price of cereals. As a result, for the period 1 July 1995 to 30 June 1996, the basic price for

slaughtered pigs of the standard quality was fixed at ECU 1 509.39 per tonne. The standard quality was defined in terms of carcase weight and lean meat content, determined as follows: - carcasses weighing 60 to less than 120 kilograms: grade E, - carcasses weighing 120 to 180 kilograms: grade R. ?
