Agricultural prices 1995/1996: basic price and buying-in price in the fruit and vegetable sector

Fruit and vegetables: agricultural prices 1995/1996. Pending its proposals for a reform of the common organization of the market, the Commission proposed maintaining the basic prices and buying-in prices for fruit and vegetables at their current levels for the 1995/1996 marketing year. The periods during which the prices would apply were: - for tomatoes and aubergines, from 1 January to 31 December; - for apricots, from 1 May to 31 August; - for peaches and nectarines, from 1 May to 31 October; - for cauliflower and dessert grapes, from 1 May to 30 April; - for lemons and pears, from 1 June to 31 May; - for apples, from 1 July to 30 June; - for mandarins, satsumas and clementines, from 1 October to 15 May; - for oranges, from 1 October to 15 July. ?

Agricultural prices 1995/1996: basic price and buying-in price in the fruit and vegetable sector

The European Parliament rejected the request by its Committee on Agriculture for a 1% increase in agricultural prices for 1995/96. Parliament approved the Commission proposal with certain amendments. It amended the calendars for opening the intervention periods and applying the target prices in order to take account of the production conditions in all the countries of the Union. The EP also called on the Commission to put forward proposals concerning the following aspects: - respect for Community preference for regional products (including garlic, asparagus and dried fruits); - review of the minimum import price system, within the framework of negotiations with the CEECs, for fresh or processed soft fruit and cherries; - grubbing-up schemes for peaches and nectarines similar to those adopted for apples; - acceptance for intervention of fruit damaged by hail; - payment of aid to producers' organisations at the latest 60 days after delivery of the product to industry.?

Fruits and vegetables - Prices and related measures for 1995/96. Council Regulation (EC) No 1542/95 maintained the basic prices and buying-in prices for fruit and vegetables at their current levels for the 1995/96 marketing year. The period during which the prices would apply were: - for lemons, from 1 July 1995 to 31 May 1996; - for cauliflower and pears, from 1 July 1995 to 30 April 1996; - for tomatoes, from 1 July 1995 to 30 November 1995; - for aubergines, from 1 July 1995 to 31 October 1995; - for peaches, from 1 July 1995 to 30 September 1995; - for nectarines, from 1 July 1995 to 31 August 1995; - for apricots, from 1 July 1995 to 31 July 1995; - for table grapes, from 1 August 1995 to 20 November 1995; - for apples, from 1 August 1995 to 31 May 1996; - for mandarins, from 16 November 1995 to 29 February 1996; - for satsumas, from 16 October 1995 to 15 January 1996; - for clementines, from 1 December 1995 to 15 February 1996; - for sweet oranges, from 1 December 1995 to 31 May 1996. ?
