Agricultural prices 1995/1996: wine, common organisation of the market COM (amend. regul. 822/87/EEC)

Wine: marketing year 1995/1996. Pending the implementation of the new COM in wine, the Commission proposed extending, for the 1995/1996 marketing year, certain deadlines which were established by regulation and which related to: - the submission of reports to Parliament and the Council on: . the maximum sulphur dioxide levels of wine, accompanied - where appropriate - by proposals, . the link between structural measures and compulsory distillation. - the determination of the rules for calculating the quantities to be distilled for each wine-growing region (uniform percentage and reference year) which were accepted following the Dublin compromise, and which had been postponed until 31.08.1995, together with the derogation granted for the specific application of the compulsory distillation procedures in Greece; - the delimitation of the trial period for certain de-acidification practices now approaching expiry, in order to be able to reach a definitive decision on these techniques; - the delimitation of the period during which it is possible to set aside, for campaigns to promote the consumption of grape juice, part of the aid intended for the use of grape musts for the purposes of manufacturing grape juice, which was extended the previous year until 31.08.1995. ?

Wine - Prices and related measures for 1995/96. The Council adopted Council Regulation (EC) No 1544/95 amending Regulation (EEC) No 822/87 on the common organisation of the market in wine. Substance: - extension in 1995/96 of the derogations currently granted to Spain for the coupage of red and white wines and acidity; - possibility, for 1994/95, of placing on the market all or part of the products that are subject to storage contracts before the end of the normal period of nine months; - determination of the rules for calculating the quantities to be distilled for each wine-growing region (uniform percentage and reference year); derogation granted for the specific application of the compulsory distillation procedures in Greece; - possibility, between the 1985/86 and 1995/96 wine years, of setting aside for campaigns to promote the consumption of grape juice part of the aid for the use of grape musts for the purposes of manufacturing grape juice, extended the previous year, until 31 August 1995; - submission of a report to the EP and the Council, before 1 April 1996, on the maximum sulphur dioxide levels of wine, accompanied, where appropriate, by proposals; - submission of a report to the EP and the Council, before the end of the 1995/96 wine year, outlining the effect of the structural measures applicable in the wine sector, accompanied, where appropriate, by proposals. ?
