## Agricultural prices 1995/1996: distillation operations of wine and the by-products (amend. regul. 2046/89/EEC)

Wine (distillation): marketing year 1995/1996. Pending the introduction of the new COM in wine, the Commission proposed postponing until 31.08.1996 the deadline for the application of Article 2(3) of the basic regulation, which stipulates that Member States could regard associations of wine growers as producers for the purposes of compulsory distillation. Before 31.03.1996 the Commission would submit a report on this matter to the Council, accompanied where necessary by appropriate proposals. The Council would give its opinion on the possible measures to be applied from 01.09.1996. ?

## Agricultural prices 1995/1996: distillation operations of wine and the by-products (amend. regul. 2046/89/EEC)

Wine (distillation) - 1995/96 marketing year. The Council adopted Regulation (EC) No 1546/95 amending Regulation (EEC) No 2046/89 laying down general rules for distillation operations involving wine and the by-products of wine-making. Substance: - Pending the introduction of the new COM in wine, postponement until 31 August 1996 of the deadline for the application of Article 2(3) of the basic regulation, which stipulated that Member States could regard associations of wine-growers as producers for the purposes of compulsory distillation; - Before 31 March 1996, the Commission would submit to the Council a report on this matter, accompanied, where necessary, by appropriate proposals. The Council would give its opinion on the possible measures to be applied before 1 September 1996. The Regulation should apply from 1 September 1995. ?
