The Council would give its opinion on the possible measures to be applied from 01.09.1996. ?

The Council adopted Regulation (EC) No 1547/95 amending Regulation (EEC) No 2332/92 as regards sparkling wines and Regulation (EEC) No 4252/88 on the preparation and marketing of liqueur wines produced in the Community. Substance: - Pending the introduction of the new COM in wine, postponement until 1 April 1996 of the deadline for the presentation of a report from the Commission to the Council on the maximum sulphur dioxide content of sparkling wines and of liqueur wines, accompanied, where necessary, by appropriate proposals. The Council would give its opinion on the possible measures to be applied before 1 September 1996. ?
