Agricultural prices 1995/1996: permanent abandonment premiums for wine-growing areas

Wine (abandonment premiums): marketing year 1995/1996. The proposal for a regulation seeks to amend Regulation (EEC) No 1442/88 which defined the scope of the permanent abandonment premiums for wine-growing areas. In order to ensure that the available resources were put to better use, it was proposed that those areas which had previously received aid for the restructuring of vineyards should be excluded from eligibility for permanent abandonment premiums. ?

The European Parliament approved the Commission proposal. Nevertheless, the EP considered that only those areas that had received financing within a period of ten years or less should be excluded from eligibility for permanent abandonment premiums. ?
