Agricultural prices 1995/1996: community vineyard register (amend. Regul. 2392/86/EEC)

Wine (vineyard register): marketing year 1995/1996. As the establishment of the Community vineyard register had fallen behind schedule in several Member States, the Commission proposed, in the context of the reform of the COM, to draw up a simplified vineyard register. It was therefore proposed that the deadline laid down for establishing the Community vineyard register would be extended until 31.12.1996 at the latest, in order to allow a start to be made by way of a simplified system and to make useful progress towards the establishment of the vineyard register in the Member States concerned. The proposal mainly provides for the following measures: - Member States which, on the date of entry into force of the proposed regulation, have not yet produced a vineyard register, or have only drawn up partial registers, should proceed to establish, before 31.12.1995, a graphic reference basis covering the entire area which is under vineyard cultivation; - Member States are to submit to the Commission, within three months following the entry into force of the Regulation, a plan showing the progress they have made in establishing their register; - the Commission will examine this plan and authorize measures which are compatible with the foreseeable needs generated by the development of the COM in this sector.?

The European Parliament approved the proposal. It called on the Commission to submit a report to the Council and the EP stating the progress made in drawing up the vineyard register no later than 30 June 1996. The Commission would submit a statement of the establishment of the register by 31 December 1996 at the latest. ?

Wine - Prices and related measures for 1995/96. The Council adopted Regulation (EC) No 1549/95 amending Regulation (EEC) No 2392/86 establishing a Community vineyard register. Substance: - authorisation to establish the vineyard register by 31 December 1996 (Community

contribution of 50%); the Member States which had only drawn up partial registers by 1 July 1995 would be authorised to complete those registers, in which case Community funding would then be limited to that of the simplified register for the areas in question. ?
