Tobacco: agricultural prices 1995/1996. For the 1995 harvest the Commission proposed: - to maintain the amount of premium, and the supplementary aid, for each variety of leaf tobacco; - to make minor changes to the guarantee thresholds by group of tobacco varieties and by producer Member State, in order to better adapt supply to demand. ?

The European Parliament approved the proposal. It called on the Commission to submit a report, together with proposals, to improve the support system and the income of producers in the Union and to adjust the quota for subsequent harvests. ?
