Agricultural prices 1995/1996: amounts of aid for seeds for the 1996/1997 and 1997/1998 marketing years

Seeds: agricultural prices 1995/1996. As seed production in the Community had to cope with foreign competition and the market adjustments introduced following the reform of the CAP, the aid granted sought to guarantee producers an equitable income in the context of a production sector meeting the needs of the market. The aid in question was to be fixed every two years for two marketing periods. The Commission proposed maintaining, for the 1996/97 and 1997/98 marketing years, the amounts of aid granted to the seed sector. The Regulation would enter into force on 1.07.1996. ?
