Decentralized Community agencies: Agency for security and health at work (amend. Regul. 2062/94/EC)

The proposal seeks to introduce technical amendments to the Regulation establishing a European Agency for Safety and Health at Work. These amendments relate to the number of members of the Agency's Administrative Board following the enlargement of the Community. The Council decided to modify the legal basis of this proposal, basing it not on Article 169 of the Act of Accession of 1994 (as proposed by the Commission) but on Article 235 of the Treaty on European Union. The Council did introduce amendments, at its meeting of 20.02.1995, which went beyond a simple technical adjustment to the Regulation and has decided, as a result, to consult Parliament on the following points: - the Administrative Board would comprise 48 members, of whom 15 would represent the Member States, 15 the employers' organizations, 15 the employees' organizations and 3 the Commission; - the members' term of office would be for 3 years and was renewable; - decisions would be taken by a majority of two-thirds of the votes. ?

Decentralized Community agencies: Agency for security and health at work (amend. Regul. 2062/94/EC)

The committee unanimously adopted a report by Mr SKINNER on a Commission proposal amending the 1994 Regulation establishing a European Agency for Safety and Health at Work in Bilbao, Spain. The proposal was needed to take account of the accession to the Community of Sweden, Finland and Austria on 1 January 1995. Parliament's report amended the Commission text to give more influence to

the representatives of both sides of industry vis-à-vis the Member States on the agency's administrative board. It also included a provision opening all areas of the agency's work to public scrutiny except where individual cases need to be kept confidential.

Decentralized Community agencies: Agency for security and health at work (amend. Regul. 2062/94/EC)

The European Parliament approved this proposal for a regulation with the following amendments: - only certain decisions should be taken by a majority of two thirds of the votes of members (and not all decisions, as proposed by the Council), and each member of the Administrative Board would have one vote (instead of two votes in certain cases); - all members of the Agency (Administrative Board, members of staff, etc.) were required to ensure the confidentiality of certain information covered by the Agency (examination of files, in particular), including after their duties had ceased. ?

Decentralized Community agencies: Agency for security and health at work (amend. Regul. 2062/94/EC)

The ESC was pleased to find that employers and workers from each Member State would be represented on the Administrative Board of the Agency, but considered that the proposal that gave two votes to each government representative could only be accepted for decisions pertaining to budgetary matters.

Decentralized Community agencies: Agency for security and health at work (amend. Regul. 2062/94/EC)

The Council adopted Regulation (EC) No 1643/95 amending the Regulation establishing a European Agency for Safety and Health at Work. The main aim of these technical amendments was to take account of the enlargement of the Community. The amendments related mainly to the composition of the Agency's Administrative Board. It consisted of 48 members, of whom: . 15 members represented the Member States; . 15 members represented the employers' organisations; . 15 members represented the employees' organisations; . 3 members represented the Commission. The term of office of members of the Administrative Board was three years and was renewable. Decisions by the Board would be taken by a majority of two thirds of the votes. The Regulation would enter into force on 10 July 1995. ?

Decentralized Community agencies: Agency for security and health at work (amend. Regul. 2062/94/EC)

The Commission presents, as a temporary measure, the progress report for the period 1996-2000, which provides a general overview of the progress, achieved in the operational set-up of the European Agency for the Safety and Health at Work, rather than a detailed performance evaluation towards its objectives. The precise evaluation of its performance, and the impact of the Agency's information activities, will be submitted to Council once the results of the extended evaluation launched are available and are analysed by the Commission. The report concentrates on the progress made in the following areas: - the information network - building the links : the aim is to link all existing occupational safety and health information through information technology (IT) to the Agency's network, and to ensure that it is easily accessible to the target users. This involves building up the IT infrastructure and expertise of the Agency, especially related to the Internet, to handle the relevant information; - information projects - developing safety and health knowledge: information projects are being undertaken by the Agency in partnership with its Focal Points with assistance from Thematic Networks, through external experts concerned on a particular topic, through studies on individual studies, or through topic centres designated to carry out a specific task for the Agency; - information services - communicating the safety and health message: the Agency shall use both its network and other media to fulfil its obligations to disseminate information on occupational safety and health as laid down by the Regulation. The Regulation foresees a role for the Agency in organising certain forms of information exchange such as conferences and seminars; - administrative arrangements. ?
