# Supplementary and amending budget 1/1995: others sections

With the exception of the Commission's administrative budget, this report dealt with the allocation of reserves provided for in the context of enlargement for the budgets of the other institutions. The rapporteur recalled the need for sound financial management and stressed that it was important for the institutions to leave margins available within the ceiling of the financial perspective, given, in particular, the unfavourable change in the ECU/FB parity. The Committee on Budgets supported its rapporteur and adopted the amendments and the motion for a resolution. Mr DANKERT (PSE, NL) stressed the need for rational and effective management of human resources as well as the need for rigour and transparency in the budget. He recalled the importance of interinstitutional cooperation, which could be enhanced. The creation of

new jobs linked to enlargement and the procedures for recruiting staff from the new Member States provided an excellent opportunity in this respect. Finally, since the latest enlargement had added two additional languages to the Union, the institutions were called upon to submit programmes to reorganise the translation services, which should also deal with the Translation Centre in Luxembourg.?

## Supplementary and amending budget 1/1995: others sections

The resolution adopted by the European Parliament: - highlighted the need for sound financial management and the institutions' desire to ensure that margins were available within the ceilings for the different categories of expenditure; - considered that a reasonable available margin needed to be maintained within the category of "Administrative expenditure"; - stressed that the distribution of the reserves provided to cater for enlargement should not be automatic and that allocations to individual budget lines should be subject to proper assessment; - considered that, in this instance, the main aim of the allocation of appropriations was to create new posts and regretted the failure by the institutions to properly justify their ability to take on new staff in line with the initial requests put forward in their draft estimates; - recalled the need for rational and effective management of human resources and repeated its request concerning the need to submit both analytical budgets and operational establishment plans with a breakdown by directorate or group of services for each institution; - pointed out that the creation of new posts and the recruitment of staff from the new Member States should provide an opportunity for stepping up interinstitutional cooperation, which in turn should enable a common set of recruitment criteria to be drawn up; - invited the institutions to present an interinstitutional programme reorganising and regulating their translation services (Translation Centre, economies of scale, work from home, use of new technologies) and asked that this matter be raised in the context of the interinstitutional trialogue.?

### Supplementary and amending budget 1/1995: others sections

The committee noted the Council's rejection at second reading (10 April) of several of the EP's amendments, concerning in particular: - in category 1 - agricultural expenditure: the reintroduction of the preliminary draft budget (PDSAB) for the accompanying measures (lines B1-500, B1-5010, B1-5012); - in category 2 - structural measures: the allocation of appropriations between the various Community initiatives following enlargement; - in category 3 - internal policy: the reintroduction of the preliminary draft budget for the information and communications sectors, other social actions (such as the Helios II programme, the EURES programme, and so on), the SAVE and Altener programmes, a stronger financial instrument for the environment and increased appropriations under the heading for growth and the environment; - in category 4 - external policy: cooperation with the developing countries in Asia and Latin America as well as other measures on cooperation (for example, a health programme combating AIDS in developing countries, rehabilitation and reconstruction measures, coordination of development policy, human rights and democracy in the developing countries, etc.). The committee therefore supported Mr Terence WYNN and re-tabled at second reading all the amendments rejected by the Council. The Committee on Budgets welcomed the fact that all of the EP's amendments to category 5 - administrative expenditure - had been taken over by the Council.?
