Conservation of fishery resources: the Baltic Sea, the Belts and the Sound (amend. Regulation (EEC) No 1866/86)

The proposal for a regulation seeks to amend for the fifth time Regulation (EEC) No 1866/86 laying down certain technical measures for the conservation of fishery resources in the waters of the Baltic Sea, the Belts and the Sound. This amendment is based on the recommendations of the 20th Sitting of the Baltic Commission (12 - 16.09.1994). Under the provisions of the Convention on fishing and the conservation of living resources in the Baltic Sea, to which the Community is party, the European Community is required to incorporate into its own legislation the measures proposed by the Baltic Commission. Under the provisions of Article XI of this Convention, the recommendations which were agreed at the above Sitting would actually become compulsory from 01.01.1995; however, a period of adjustment was to be provided up to 01.06.1995 for certain recommendations relating to mesh sizes. The proposed measures relate primarily to: - the ban on fishing for cod in the Baltic Sea, the Belts and the Sound from 01.06.1995 to 31.08.1995, - the strict application of the ban which forbids vessels from carrying on board fishing tackle other than that of an authorized mesh size when fishing for cod, - adjustments for fixed mesh sizes when fishing for cod and flat-fish, - technical arrangements relating to the selectivity of fishing tackle, - the introduction of certain restrictions to the percentage of incidental catches of this type, in order to ensure that current opportunities for cod fishing are put to better use. ?

The aim of this amended proposal was to improve slightly the presentation of the text of the initial proposal (the inverted commas in the tables in Annex II of the initial proposal were removed). ?

The ESC endorsed the Commission proposal as it formed part of a rational fisheries policy in tune with the resources available. It recommended that fitting and effective measures be adopted to monitor vessels from all the contracting parties to the Baltic Sea Convention that fished in the area. The ESC regretted that despite the EU accounting for 65% of catches in the area it only had one vote to defend the interests of the Member States. It called for more vigorous efforts to change this so that the number of EU votes was properly representative of the Member States.

Conservation of fishery resources: the Baltic Sea, the Belts and the Sound (amend. Regulation (EEC) No 1866/86)

- OBJECTIVE: to amend for the fifth time Regulation (EEC) No 1866/86 laying down certain technical measures for the conservation of fishery resources in the waters of the Baltic Sea, the Belts and the Sound in order to take account of the recommendations of the Baltic Commission (sittings of 12 - 16.09.1994), which the Community is obliged to respect. - SUBSTANCE: In accordance with the provisions of the Convention on fishing and the conservation of living resources in the Baltic Sea, namely the Gdansk Convention to which the Community is party, the European Community is required to incorporate into its own legislation the measures provided by the Baltic Commission which were adopted at its 19th and 20th sittings. The measures proposed relate primarily to: . the ban on fishing for cod in the Baltic Sea, the Belts and the Sound from 01.06.1995 to 31.08.1995, . the strict application of the ban which forbids vessels from carrying on board fishing tackle other than that of an authorized mesh size when fishing for cod, . adjustments for fixed mesh sizes when fishing for cod and flat-fish, . technical arrangements relating to the selectivity of fishing tackle, . the introduction of certain restrictions to the percentage of incidental catches of this type - the aim being to ensure that current opportunities for cod fishing are put to better use. - ENTRY INTO FORCE: the recommendations which were agreed at the sittings of the Baltic Commission are to become compulsory from 01.01.1995; however, a period of adjustment is to be provided up to 01.06.1995 for certain recommendations relating to mesh sizes. The regulation is to enter into force on 04.10.95. ?
