Dried fodder: common organisation of the markets COM

Following the accession of Austria, Finland and Sweden to the European Union, the proposal sought to establish these countries' national guaranteed quantities (NGQs) for dried fodder in accordance with the limits laid down for the other Member States, and consequently to adapt the maximum guaranteed quantities (MGQs) for the Community. An MGQ of 4,412,400 tonnes of dehydrated fodder, divided among the Member States, was instituted for each marketing year. For the three new Member States the NGQ was as follows: - Austria: 4,400 tonnes - Finland: 3,000 tonnes - Sweden: 11,000 tonnes. The MGQ for sun-dried fodder was set at 443,500 tonnes, divided among Greece, Spain, France, Italy and Portugal. ?

The European Parliament approved this proposal for a regulation in accordance with the procedure laid down in Rule 143 of its Rules of Procedure (procedure without report) and with a single amendment: the EP allocated Greece a NGQ (national guaranteed quantity) of 50 000 tonnes of dehydrated fodder instead of the 32 000 tonnes initially proposed (see Regulation (EC) No 603/95). ?

The ESC essentially endorsed the Commission proposal. It noted that, whilst the Austrian national guaranteed quantities for dried fodder largely satisfied the production requirements, the same could not be said of Finland and Sweden, both of which had produced considerably more artificially dried fodder in the years preceding the 1992/1993 reference period.

OBJECTIVE: Following the accession of Austria, Finland and Sweden to the European Union, to establish their national guaranteed quantities (NGQ) for dried fodder, in accordance with the limits laid down for the other Member States, and consequently to adapt the maximum guaranteed quantities (MGQ) for the Community. COMMUNITY MEASURE: Council Regulation (EC) No 1347/95 amending Regulation (EC) No 603/95 on the common organisation of the market in dried fodder. SUBSTANCE: An MGQ per marketing year of 4 412 400 tonnes of dehydrated fodder is established, divided among the Member States. For the three new Member States, the NGQ is as follows: . Austria: 4 400 tonnes; . Finland: 3 000 tonnes; . Sweden: 11 000 tonnes. With regard to sun-dried fodder, the MGQ is 443 500 tonnes, divided among Greece, Spain, France, Italy and Portugal. ENTRY INTO FORCE: 22 June 1995. The Regulation shall apply from 1 April 1995. ?
