Third pan-European transport conference

The Transport Committee adopted the draft resolution on a pan-European transport policy (rapporteur Mr Luttge PSE, D). In returning to the basic principles and concepts laid down in the declarations of Prague and Crete, which were the venues for the previous two trans-European conferences, the rapporteur put forward the idea of a third conference, proposing to the Commission that this be held in Helsinki in June 1997. He went on to outline both the framework and the criteria to be adopted for the organisation and make-up of the meeting, and the general themes for discussion. Priority items on the conference agenda would include a revision of the corridors scheme presented at the Crete meeting, by the inclusion of a Euro-Arctic corridor and multimodal links in the former Yugoslavia; the opening of a structured dialogue with the CIS, on the same lines as that held with the CEECs; the devising of a plan for using multimodal corridors to extend trans-European networks not only towards Asia and the Middle East but also towards Africa and the ACP countries. ?

Third pan-European transport conference

In adopting the report by Mr Gunter LÜTTGE (PSE, D), the European Parliament took stock of the third pan-European Transport Conference which the Commission was to hold in Helsinki in June 1997. The main Conference themes were to be: cross-border problems, planning, price setting and research. Parliament proposed that the Conference should extend the preliminary work which was started in Prague and Crete and that it should focus on the problems which will constitute the challenges of the years ahead, namely the rational use of trans-European networks, transport security, the relationship between transport and the environment and the financing of infrastructures. Parliament recognized the importance of revising the corridors scheme, as presented in Crete, and expressed the wish that this scheme should mention and include two regions which did not appear in the first list, in particular the Euro-Arctic corridor for north-eastern Europe (Sweden, Finland and Russia) and the necessary multimodal links in the territory of the former Yugoslavia. Finally, Parliament called for the establishment of close coordination with the CIS countries, along the same lines as the 'structured dialogue' held with the CEECs, in the field of trans-European transport and networks. ?
