### Banana, fruit and vegetables sector

This proposal for a regulation aimed to amend Regulation (EEC) No 404/93 on the common organisation of the market in bananas: . Since this Regulation currently covered fig bananas, which presented totally different characteristics and were marketed in a totally different way to the bananas most commonly marketed in the Community, the Commission proposed excluding this type of banana from the regulation and including it in Regulation (EEC) No 1035/72 on the COM in fruit and vegetables, along with other tropical fruit, and to amend at the same time Regulation (EEC) No 2658/87 on nomenclature and the Common Customs Tariff (CCT). It was also important to amend Regulation (EEC) No 404/93 since the concept of "marketed quantities" used a basis to determine the reference quantities for operators when adopting the regulation was too complex (system with the dual objective of not disrupting the normal trading relations between persons operating at different points in the banana marketing chain while also allowing some evolution of trading structures). The current regulation proposed basing the allocation by volume and the administration of the tariff quota on the criterion of effective importation of bananas. . Similarly, Regulation (EEC) No 404/93 provided for the possibility of adjusting the tariff quota in exceptional circumstances affecting production or import conditions relating to this product on the basis of a review of the forecast supply balance. Indeed, experience showed that this arrangement should be developed in order to ensure the continuity of Community supplies while also allowing appropriate remedy for any serious damage suffered in such circumstances by Community producers or by certain categories of banana operators. . Finally, the proposal stipulated that, in cases of force majeure, ACP producing states should be permitted to supply the Community with bananas of other origins. This amendment also provided for the possibility of reallocating traditional and non-traditional quantities from ACP countri

majeure. This reallocation should be temporary and take place between ACP countries located in the same geographical zone, as listed in the annex to the proposal. The conditions for applying these two mechanisms were adopted according to the management committee procedure.

#### Banana, fruit and vegetables sector

The report was unanimously approved. As regards the amendments proposed by the Commission, the rapporteur was firstly of the opinion that the exclusion of fig bananas from the common organization for bananas, due to their limited production and their status as an exotic or luxury product, and as a result the inclusion of fig bananas in the COM for fruit and vegetables, raised a number of problems which related particularly to their definition and identification. He was therefore in favour of maintaining the status quo, though considered, on the other hand, that there were grounds for introducing the criterion of "actual import". The rapporteur also subscribed to the Commission's criteria which sought to reduce the reference period for the allocation of operators' import duties and, in this regard, he proposed fixing this period to a single calendar year instead of two (as proposed by the Commission). The report took the view that the COM's operating balance could be considered as a positive one. In this context the rapporteur stressed the importance of maintaining the preferences granted to ACP countries and also called on the Commission to present again a proposal for a programme of diversification and technical aid in favour of the banana-producing countries of Latin America, as the Council had never adopted the previous proposal. Finally, the report held that the complaints of the United States' administration, which threatened retaliatory measures, were unjustified.?

The ESC approved the Commission proposal with the exception of the exclusion of fig bananas from the scope of the COM in bananas. It could not be sure that this exclusion would not lead to distortions in the import system. The ESC also felt that the Commission should, when considering banana supply, take account of the working conditions in the producing countries and urge the exporting countries to ensure that social conditions were respected and workers? human rights protected in such production. Finally, the concept of ?force majeure? in the Commission proposal should include war that seriously affected the production possibilities of a given country.

Parliament approved the proposal for a regulation and then referred to committee the report of Mr Juan COLINO SALAMANCA (PSE, E). The amendments approved by Parliament at the plenary sitting of October I (1995) were as follows: - the title was amended: the regulation seeks only to amend Regulation (EEC) No 404/93 (and not this regulation and Regulation (EEC) No 1035/72). In the same context, Parliament took the view that the exclusion of fig bananas from the common organization for bananas and, consecutively, their inclusion in the COM for fruit and vegetables, was not desirable. It therefore recommended maintaining the status quo (and as a result removed all reference to fig bananas, including Annex I which included this type of banana); - Parliament considered that the Commission should present proposals which seek to remove the current restrictions on the access of banana production to the economic area of the European Union, without affecting the legitimate interests of both Community producers and those in the ACP countries; - it proposed fixing the reference period for the allocation of import duties to a single calendar year instead of two (the Commission's proposal); - to cases of "force majeure", in which the ACP countries were permitted to import products of other origin, it added those cases where there was endemic civil war and the absence of a legitimately recognized government; - as regards the conditions governing the temporary re-allocation of traditional and non-traditional quantities, as attributable to cases other than "force majeure", Parliament held that the transfer should not necessarily take place between ACP States from the same geographic zone; - finally, Parliament called on the Commission to present a report (by 31.12.1995 at the latest) which would be accompanied by appropriate proposals relating to the operation of this regulation (taking account particularly of the flow of trade in Community bananas and in bananas from non-member and ACP countries when applying this regulation). ?

In adopting the report by Mr COLINO SALAMANCA (PSE, E), the European Parliament approved this proposal for a regulation with the amendments adopted at the plenary sitting of 12 October 1995. ?

With the European Parliament's Opinion now available, the Council resumed its discussion of the common organization of the market in bananas on the basis of the proposal for Regulation submitted by the Commission in April 1995. ?

#### Banana, fruit and vegetables sector

In its amended proposal, the Commission decided to comply with Parliament's wishes and continue to include fig bananas in the market organization for bananas. The title of the regulation is changed accordingly (to 'Council Regulation [EEC] amending Regulation [EEC] No 404/93 on the common organization of the market in bananas'), and all references to the exclusion of fig bananas from the common organization for bananas are removed.?
