Volume of the annual quota for the import of bananas, 1995 enlargement

This proposal for a regulation aimed to adjust the volume of the tariff quota for imports of bananas from third countries and non-traditional ACP bananas to the Community laid down by Regulation (EEC) No 404/93, following the accession of the three new Member States of the Union. The objective of this proposal was to adapt the Regulation to take account of the consumption needs of the new Member States. These needs had been assessed on the basis of the net average quantities of bananas imported over the last three years for which figures were available (1991-1993). The adjustment totalled 353 000 tonnes (net weight). The regulation should apply from 1 January 1995. ?
