## EC/Lithuania Europe Agreement

This proposal for a Council and Commission decision aimed to conclude a Europe Agreement between the European Communities and their Member States, of the one part, and Lithuania, of the other part. It was a preferential agreement designed to establish a close and lasting relationship between the parties and create an appropriate framework for the gradual integration of this country into the Union. It was concluded for an indefinite period and was based on respect for democratic principles and human rights. With regard to trade and accompanying measures, the Europe Agreement fully integrated the provisions of the agreement on the liberalisation of trade which was signed on 18 July 1994. It included political dialogue at the highest possible level together with a transitional period expiring on 31 December 1999 for the definitive establishment of the Lithuania-European Communities association. The agreement also contained provisions concerning: - the right of establishment, - the free movement of workers, - the provision of services (with a clause maintaining the status quo), the free movement of capital, - economic, cultural and financial cooperation. The agreement also made provision for the establishment of an Association Council responsible for supervising the implementation of the agreement and with the power to take decisions in specific cases provided for in the agreement. An Association Committee and a Parliamentary Committee were also established. Finally, and for the first time in a Europe Agreement, provisions were included on cooperation in the prevention of illegal activities (including drug trafficking, organised crime, illegal trade in nuclear materials and illegal immigration, taking account of the principle of readmission). The agreement replaced the agreement on trade and economic and commercial cooperation between the Community and Lithuania which entered into force on 1 February 1993 and, as regards trade and accompanying measures, the agreement on the liberalisation of trade which entered into force on 1 January 1995.?

## EC/Lithuania Europe Agreement

In a letter addressed to the European Parliament, the Council informed the President of the Parliament that the EC-Lithuania agreement had been signed by the parties on 12 June 1995 and that the assent of the European Parliament should be given to the agreement on the basis of

the draft decision, which it attached in an annex to the letter. As well as stating that the EC-Lithuania Europe Agreement is approved by the parties, the draft decision stipulates the position which should be adopted by the Community within the Association Council and Committee (when the latter acts on the authorization of the Association Council) which are set up under the Agreement: this position is adopted by the Council at the Commission's instigation, or, if necessary, by the Commission in accordance with relevant provisions of the Treaties establishing the EC, the ECSC and EURATOM. It was also stated that the President of the Council should, under the terms of the Agreement, chair the Association Council and should in this capacity present the Community's position (at the same time a representative from the Commission would chair the Association Committee and present the Commission's position). ?

## EC/Lithuania Europe Agreement

The Committee unanimously adopted the report by Mr Hans-Gert POETTERING on the European association agreements between the European Union and Lithuania. The Committee proposed that the European Parliament give its assent to this Association Agreement. The prospects for the accession of the Baltic States to the Union are clearly stated. This European Agreement replaces the previous agreements on trade and economic and commercial cooperation between the Community and each of the Baltic States. It fully integrates the free-trade agreement which entered into force on 1 January 1995 and also proposes three additional fields of intervention: - multilateral political dialogue - the fight against illegal activities - cultural cooperation. The Committee called on Lithuania to participate fully in the multilateral political dialogue which had been established between all potential new members of Central and Eastern Europe and the European Union. For the first time in a European agreement provisions were made for close cooperation in the fight against illegal activities, in particular against corruption, illegal immigration, trafficking in industrial-waste, counterfeit goods and drugs, and against organized crime. On a cultural level the agreement seeks to provide support for the audiovisual industry, to harmonize rights relating to international broadcasting and to promote language learning for the Russian-speaking population. The Baltic States would also be able to participate in a large number of Community programmes and projects in many different sectors. The Committee drew attention to two important aspects of the agreements: - Respect for democratic principles, human rights and the market economy. These principles are the subject of a suspensive clause (the so-called "democracy clause"), which stipulates that the agreement will be suspended in the event of a flagrant violation of its principles. To this effect, an Association Committee and a Joint Parliamentary Committee will be set up to verify that all the provisions of the association agreements are being implemented. - Intra-regional cooperation between the Baltic States and between these States and Russia, which will help establish stability and security in the region as a whole. The agreements are concluded for an unspecified period. However, in the case of Lithuania the agreement provides for a transition period which will run until the end of 1999. ?

# EC/Lithuania Europe Agreement

Recalling the various stages involved in the run-up to the signature of the Europe Agreements by the Council of Ministers in June 1995, Commissioner van den Broek announced that Estonia and Lithuania had already approved the Agreements. There were still some problems in Lithuania regarding ratification because its legislation had to be amended in order to allow foreigners to acquire property. In comparison to the agreements concluded with the CEECs, these Agreements provided for cooperation in the fight against crime. A series of measures, including special regional assistance, had been implemented to prepare for their pre-accession strategy, even before ratification of the Europe Agreements by the countries in question. As a result, even taking into consideration the significant economic and social progress made by the Baltic republics, the Commissioner called on the European Parliament to approve the Europe Agreements concluded with these countries in order to eliminate any obstacles to the launch of the pre-accession strategy.

# EC/Lithuania Europe Agreement

OBJECTIVE: conclusion of a European association agreement between the Communities and Lithuania. COMMUNITY MEASURE: Decision 98/150/EC/ECSC/Euratom of the Council and the Commission on the conclusion of the Europe Agreement establishing an association between the European Communities and their Member States, of the one part, and the Republic of Lithuania, of the other part. SUBSTANCE: this is a preferential agreement establishing a close and lasting association between the parties and creating an appropriate framework for the gradual integration of this country into the Union. It is concluded for an indefinite period and is based on respect for democratic principles and human rights. With regard to trade and the accompanying measures, the Europe Agreement fully integrates the provisions of the agreement on the liberalization of trade which entered into force on 1 January 1995 and progressively establishes a free trade area over a six year period (from 1 January 1995). It includes political dialogue at the highest possible level and has a transitional period expiring on 31 December 1999 for the definitive establishment of the Lithuania-European Communities association. This agreement also has provisions covering: - right of establishment, - free movement of workers, - supply of services (with a clause maintaining the status quo), - free movement of capital, economic, cultural and financial cooperation: the various areas of cooperation include nuclear safety, environment, transport, banking services, monetary policy, social cooperation, consumer protection, tourism and customs cooperation. Provisions are also made with regard to justice and home affairs (action against drugs and money laundering, action against organized crime and corruption, illegal trading in nuclear materials and illegal immigration, taking account of the principles of readmission). The agreement also makes provision for the establishment of an Association Council to supervise the implementation of the agreement and with the power to take decisions in the specific cases provided for in the agreement. An Association Committee and a Parliamentary Committee are also established. The agreement replaces the agreement on trade and commercial and economic cooperation between the Community and Lithuania which entered into force on 1 February 1993, and as regards trade and the accompanying measures, the agreement on free trade which entered into force on 1 January 1995. ENTRY INTO FORCE: the EC-Lithuania association agreement enters into force on 1 February 1998.?
