1995/0134(CNS) - 07/06/1995 Legislative proposal

OBJECTIVE: to amend Directive 77/93/EEC by replacing the acronym "EEC" with the acronym "EC" in phytosanitary certificates.

SUBSTANCE: It is envisaged that following the adoption of this proposal for a directive by the Council, the amendment will be inserted in the proposal for legislative consolidation of Directive 77/93/EEC, currently underway, which will then be before the Council. Phytosanitary certificates using the "EEC" acronym may be used until 1 July 1996. ?
