## Wheeled agricultural and forestry tractors: roll-over protection structures

**PURPOSE:** to codify Council Directive 87/402/EEC on roll-over protection structures mounted in front of the driver's seat on narrow-track wheeled agricultural and forestry tractors.

**LEGAL BASIS:** Article 114 of the Treaty on the Functioning of the European Union (TFEU).

**CONTENT:** the purpose of this proposal is to undertake a codification of Council Directive 87/402/EEC of 25 June 1987 on roll-over protection structures mounted in front of the driver's seat on narrow-track wheeled agricultural and forestry tractors.

The new Directive will supersede the various acts incorporated in it. This proposal fully preserves the content of the acts being codified and hence does no more than bring them together with only such formal amendments as are required by the codification exercise itself.

**BUDGETARY IMPLICATION:** this proposal has no implication for the EU budget.

## Wheeled agricultural and forestry tractors: roll-over protection structures

The Committee on Legal Affairs adopted the report drafted by Sajjad KARIM (ECR, UK) on the proposal for a directive of the European Parliament and of the Council on roll-over protection structures mounted in front of the driver's seat on narrow-track wheeled agricultural and forestry tractors (codified text).

It recommended that the European Parliament's position adopted at first reading, under the ordinary legislative procedure, should be to take over the Commission proposal as adapted to the recommendations of the Consultative Working Party of the legal services of the European Parliament, the Council and the Commission.

## Wheeled agricultural and forestry tractors: roll-over protection structures

The European Parliament adopted by 536 votes to 13, with 7 abstentions, a legislative resolution on the proposal for a directive of the European Parliament and of the Council on roll-over protection structures mounted in front of the driver's seat on narrow-track wheeled agricultural and forestry tractors (codified text).

Parliament adopted its position at first reading, under the ordinary legislative procedure, taking over the Commission proposal.

According to the Consultative Working Party of the legal services of the European Parliament, the Council and the Commission, the proposal in question contains a straightforward codification of the existing texts without any change in their substance.

## Wheeled agricultural and forestry tractors: roll-over protection structures

As announced in Official Journal C 153 of 21 May 2014, the Commission decided to withdraw this proposal, which had become obsolete.
