Wheeled agricultural or forestry tractors: installation, location, operation and identification of the controls

PURPOSE: to undertake a codification of Council Directive 86/415/EEC on the installation, location, operation and identification of the controls of wheeled agricultural or forestry tractors.

PROPOSED ACT: Directive of the European Parliament and of the Council.

LEGAL BASE: Article 114 of the treaty on the Functioning of the European Union (TFEU).

CONTENT: the purpose of this proposal is to undertake a codification of Council Directive 86/415/EEC of 24 July 1986 on the installation, location, operation and identification of the controls of wheeled agricultural or forestry tractors.

The new Directive will supersede the various acts incorporated in it. This proposal fully preserves the content of the acts being codified and hence does no more than bring them together with only such formal amendments as are required by the codification exercise itself.

BUDGETARY IMPLICATION: this proposal has no implication for the EU budget.

Wheeled agricultural or forestry tractors: installation, location, operation and identification of the controls

The Committee on Legal Affairs adopted the report drafted by Sajjad KARIM (ECR, UK) on the proposal for a directive of the European Parliament and of the Council on the installation, location, operation and identification of the controls of wheeled agricultural or forestry tractors (codified text).

It recommended that the European Parliament?s position adopted at first reading, under the ordinary legislative procedure, should be to take over the Commission proposal as adapted to the recommendations of the Consultative Working Party of the legal services of the European Parliament, the Council and the Commission.

Wheeled agricultural or forestry tractors: installation, location, operation and identification of the controls

The European Parliament adopted by 579 votes to 16, with 10 abstentions, a legislative resolution on the proposal for a directive of the European Parliament and of the Council on the installation, location, operation and identification of the controls of wheeled agricultural or forestry tractors (codified text).

Parliament adopted its position at first reading, under the ordinary legislative procedure, taking over the Commission proposal.

According to the Consultative Working Party of the legal services of the European Parliament, the Council and the Commission, the proposal in question contains a straightforward codification of the existing texts without any change in their substance.

Wheeled agricultural or forestry tractors: installation, location, operation and identification of the controls

As announced in Official Journal C 153 of 21 May 2014, the Commission decided to withdraw this proposal, which had become obsolete.
